ACCREDITATION AND AFFILIATIONS

IUGS was founded in 1979 and is incorporated in the Commonwealth of Dominica, an independent country that is a member of the British Commonwealth of Nations. The University operates under a permit from the Ministry of Education and Human Resource Development of Dominica. IUGS is accredited by the National Accreditation Board Dominica. Accreditation from a sovereign country is the highest form of accreditation.

In addition, the University has:
